### **REPORT (2004) OF THE COUNCIL FOR TRADE IN GOODS**

In accordance with the "Procedures for an Annual Overview of WTO Activities and for Reporting under the WTO" (WT/L/105), the Council for Trade in Goods is to report each year to the General Council on the activities in the Council as well as in the subsidiary bodies. The reports are to be "factual in nature, containing an indication of actions and decisions taken, with cross references to reports of subordinate bodies and could follow the model of the GATT 1947 Council reports to the CONTRACTING PARTIES".

Since the CTG 2003 annual report (G/L/665) was issued, the Council for Trade in Goods has met seven times in formal session on the following dates: 26 January 2004 (minutes contained in document G/C/M/72); 27 April 2004 (G/C/M/73 and Corr.1); 5 July 2004 (G/C/M/74); 1 October 2004 (G/C/M/75<sup>1</sup>); and 25 November 2004 (G/C/M/78<sup>1</sup>). It also held dedicated sessions on textiles and clothing on: 25 October 2004 (G/C/M/76<sup>1</sup>); and 11 and 19 November 2004 (G/C/M/77<sup>1</sup>).

#### **1.** Election of Chairperson for the Council for Trade in Goods

At its meeting of <u>27 April</u>, the Council elected H.E. Ambassador Alfredo Vicente Chiaradia (Argentina) as its Chairman for 2004. Following Ambassador Chiaradia's departure from Geneva, at its meeting of <u>25 October</u>, the Council elected H.E. Ambassador Choi Hyuck (Republic of Korea) as his successor.

### 2. Appointment of Officers for the subsidiary bodies of the Council

At the same meeting, the Council agreed to proceed on the understanding that as concerns Vice-Chairpersons, it would be for the subsidiary bodies to decide if they needed a Vice-Chairperson in cases where the option existed under the respective Agreement and/or rules of procedure, and for the respective Chairperson to hold the necessary consultations.

#### 3. Periodic reports of the Market Access Committee

At its meetings on  $\underline{27}$  April and  $\underline{1}$  October, the Council took note of the periodic reports (in documents G/MA/153 and G/MA/154) of the Committee on Market Access.

#### 4. Waivers under Article IX of the WTO Agreement

Introduction of Harmonized System 1996 changes into WTO Schedules of tariff concessions

 Requests for a waiver (Israel – G/L/670, G/C/W/482, G/L/687, G/C/W/492; Malaysia – G/L/676, G/C/W/485; Panama – G/L/672, G/C/W/483; Pakistan – G/L/673, G/C/W/484;
 Argentina – G/L/693, G/C/W/493)

At its meeting on <u>27 April</u>, the Council considered requests from Israel, Malaysia, Panama and Pakistan for waivers in connection with the introduction of HS96 changes to their Schedules of concessions. The Council approved the waiver requests and recommended that the draft decisions contained in the cited G/C/W/- documents be forwarded to the General Council for adoption.

At its meeting on <u>1 October</u>, the Council considered requests from Israel and Argentina in connection with the introduction of HS96 changes to their Schedules of tariff concessions. The Council approved the waiver requests and recommended that the draft decisions contained in G/C/W/492 and G/C/W/493 be forwarded to the General Council for adoption.

(b) Introduction of Harmonized System 2002 changes into WTO Schedules of tariff concessions – Requests for a waiver (G/C/W/477, G/C/W/500/Rev.1)

At its meetings on <u>26 January</u> and <u>25 November</u>, the CTG recommended that the draft waiver decisions contained in documents G/C/W/477 and G/C/W/500/Rev.1 be forwarded to the General Council for adoption.

At its meeting on  $\underline{25}$  November, Albania introduced its request for a waiver as contained in document G/C/W/504.

#### 5. EC enlargement

At its meeting on <u>1 October</u>, the Council agreed on the extension of the deadline set out in the communication from the EC (G/L/695) and agreed to refer the matter to the General Council for adoption.

# 6. Review of the operation of the Agreement on Trade-Related Investment Measures under Article 9

(a) Review of the operation of the TRIMs Agreement under Article 9

At its meetings on <u>26 January</u>, <u>27 April</u>, <u>5 July</u>, <u>1 October</u> and <u>25 November</u>, the Council took note of the statements made regarding, *inter alia*, the submissions by Brazil and India in documents G/C/W/428 and Job(04)/93. The Chairman agreed to undertake informal consultations, and to inform the Council of the results of his consultations at an appropriate time.

(b) Pakistan's request for extension of the transition period under the TRIMs Agreement

At its meetings on <u>26 January</u>, <u>27 April</u>, <u>5 July</u> and <u>1 October</u>, the Council had before it Pakistan's request for the extension of the transition period under the TRIMs Agreement in document G/C/W/478. The Chairman said that he was prepared to conduct informal consultations on this matter as soon as interested Members were ready to engage.

# 8. Major Review of the Implementation of the Agreement on Textiles and Clothing in the Third Stage of the Integration Process pursuant to Article 8.11 of the Agreement

At its meeting on <u>1 October</u>, the Council commenced with the Major Review of the Implementation of the Agreement on Textiles and Clothing in the Third Stage of Integration. The

Council had before it the Comprehensive Report of the TMB to the CTG (G/L/683) and the Background Statistical Information with Respect to Trade in Textiles and Clothing (G/L/692). Twenty-one members of the International Textiles and Clothing Bureau (ITCB) circulated a communication contained in document G/C/W/495. Dedicated sessions were held on <u>25 October</u> and <u>11 November</u>, as well as several informal consultations. Informal consultations were held on <u>25 October</u> and <u>8 November</u> on a specific topic. At the meeting on <u>25 November</u>, the Chairman reported on the results of the dedicated sessions on 25 October and 11 November. Following the Chairman's report, the CTG suspended consideration of the item to allow for further discussions on the Draft Report with conclusions to finalize the Major Review process.

#### 9. Post-ATC Adjustment-Related Issues

At its meeting on <u>1 October</u>, one Member introduced an "Initial Submission on Post-ATC Adjustment-related Issues" (G/C/W/496). This Initial Submission was co-sponsored by six other Members. Three additional Members joined as co-sponsors (G/C/W/496/Rev.1). In informal consultations on 26 October, another Member introduced a second submission under the item "Contribution to the Debate on Post-ATC Related-Issues" (G/C/W/497). The Chair consulted informally on this item on 26 October and 19 November. At the CTG meeting on <u>25 November</u>, the Chairman provided an oral report to the Council on the results of the consultations. The Chairman will convene informal consultations at an appropriate time. The item will be discussed at a subsequent meeting of the CTG.

### 10. Transitional Review under paragraph 18 of the Protocol on the Accession of the People's Republic of China

At its meeting on <u>25 November</u>, the Council <u>took note</u> of the reports of the CTG subsidiary bodies which had carried out their reviews and carried out the CTG-specific review with respect to the information requirements stipulated in Annex 1A of the Protocol of Accession. The Council <u>agreed</u> to send the report (G/L/722), together with the reports of the subsidiary bodies, to the General Council.

#### 11. Notifications

#### Status of notifications under the provisions of the Agreements in Annex 1A of the WTO Agreement

At its meeting on <u>5 July</u>, the Council took note of the latest revision of the status of notifications contained in document G/L/223/Rev.11 and agreed that the G/L/223 series should be circulated once rather than twice a year.

#### 12. Consideration of annual reports of subsidiary bodies of the CTG

At its meeting on <u>25 November</u>, the Council took note of the annual reports of its subsidiary bodies.
