

**COMMITTEE ON AGRICULTURE (REGULAR MEETINGS)
GENERAL COUNCIL OVERVIEW OF WTO ACTIVITIES (2008)**

Report by the Chairperson

The present report on the regular meetings of the Committee on Agriculture held in 2008 is submitted on the responsibility of the Chairperson, Ms. Valeria Csukasi of Uruguay, as agreed by the Committee at its meeting on 18 September 2008.

-
1. The Committee on Agriculture held regular meetings on 18 March and 18 September 2008.¹ A further regular meeting is scheduled for 4 December 2008.
 2. In accordance with Article 18.1 of the Agreement on Agriculture ("the Agreement"), at each of these meetings the Committee reviewed progress in the implementation of commitments negotiated under the Uruguay Round reform programme. This review process was undertaken on the basis of notifications submitted by Members in the areas of market access, domestic support, export subsidies and under the provisions of the Agreement relating to export prohibitions and restrictions. In total, 104 notifications in these areas were subject to review by the Committee. At each of its meetings, the Committee also reviewed the overall position with respect to compliance with the notification obligations under Article 18.2 and other relevant provisions of the Agreement. The current situation regarding the significant number of overdue notifications was underlined. A document showing the current status of compliance with notification requirements is annexed to this report.
 3. The Committee addressed a wide range of general and specific matters relevant to the implementation of commitments that were raised independently of notifications under the provisions of Article 18.6 of the Agreement.
 4. The follow-up to the Decision on Measures Concerning the Possible Negative Effects of the Reform Programme on Least-Developed and Net Food-Importing Developing Countries is monitored annually by the Committee on the basis, *inter alia*, of Table NF:1 notifications by donor Members as well as contributions by the observer organizations. The next monitoring exercise is to be undertaken at the November meeting of the Committee. The WTO list of Net Food-Importing Developing Countries² remains unchanged as no new application has been received since 2005.

5. The Committee maintains a standing item on its agenda relating to implementation issues, both in the framework of its follow-up to the Decision by the Doha Ministerial Conference on Implementation-Related Issues and Concerns³, as well as in the framework of issues and proposals referred to it by the General Council.⁴

6. On 18 September, the Committee held its Seventh Transitional Review under paragraph 18 of the Protocol on the Accession of the People's Republic of China (G/AG/25).

7. The following international intergovernmental organizations have regular observer status in the Committee: the FAO, the IMF, the International Grains Council, the OECD, UNCTAD, the World Food Programme and the World Bank. At present, no consensus has been reached as regards requests for observer status by twelve other international/intergovernmental organizations.⁵

8. The Committee adopted the following schedule for the Committee's regular meetings in 2009: 12-13 March, 18-19 June, 21-22 September and 19-20 November.
